RELEASE AND INDEMNITY AGREEMENT

I state that I wish to participate in activities offered by the Boeing Employees Stamp Club, (hereinafter referred to as the “Stamp Club”) a Boeing Recreation Club. I RECOGNIZE THAT ANY STAMP CLUB ACTIVITIES MAY INVOLVE CERTAIN RISKS. I certify that I am aware of the risks involved in this activity, including but not limited to, the actions of any other club members, any participants or any other persons all of which may result in personal injury, death, property damage and other losses.

In consideration for the right to participate in Stamp Club activities, I HEREBY RELEASE THE STAMP CLUB AND ITS INSTRUCTORS AND MEMBERS AND THE BOEING COMPANY FROM ANY AND ALL LIABILITY, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR IN ANY WAY CONNECTED WITH MY PARTICIPATION IN ANY STAMP CLUB ACTIVITIES. I PERSONALLY ASSUME ALL RISKS IN CONNECTION WITH THESE ACTIVITIES, AND FURTHER AGREE TO INDEMNIFY THE STAMP CLUB AND ITS MEMBERS AND INSTRUCTORS, AND THE BOEING COMPANY FROM ALL LIABILITY, CLAIMS AND CAUSES OF ACTION WHICH I MAY HAVE ARISING FROM MY PARTICIPATION IN CLUB ACTIVITIES. The terms of this agreement will serve as a release and indemnity agreement for my heirs, personal representative, and for all members of my family, including any minors.

I further state that I am eighteen (18) years of age or older and legally competent to sign this release, that I understand these terms are contractual and not a mere recital, and that I have signed this document as my own free act. Parents or legal guardians must sign for all persons under eighteen (18) years of age.
